### **Supplementary Motion**

#### **DISCIPLING NEW GENERATIONS**

Moved by Ms Lilly Bures Seconded by The Rev'd Ben Woodd

This Synod, recognising the value of young people in the Adelaide diocese and the vital importance of discipling new generations of faith, requests Diocesan Council:

- 1. prepare and distribute a report detailing a comprehensive picture of the current youth and kids' ministries within the diocese;
- 2. research and report on available resources for training and equipping churches for ministry with young people;
- 3. convene a forum to discuss those reports and share the experience and knowledge of those involved in youth and kids' ministries within the diocese and beyond; and
- 4. produce a proposal, before the next session of Synod, to be considered by the next session of Synod, for the growth and development of youth and kids' ministry within the diocese.

The proposal might include, but not be limited to:

- a) the creation of partnerships between youth and kids' ministries and others within the diocese,
- b) the provision of training and resources to equip churches to minister to young people, and
- c) consideration of the renewal of a diocesan youth event and the role of diocesan youth and kids ministry co-ordinator.

### **Supplementary Question**

Could the Secretary of Synod please provide an explanation as to why the declared income for Holy Trinity is only \$161,704. Given the letter 7 October 2022, tabled last Synod, requested an explanation as to "how it is that Holy Trinity could engage eight licenced clergy and a number of paid employees, whose total remuneration might be reasonably estimated to be comfortably in excess of \$1.0m per annum, from parish income of only \$55,220?" What action is being taken in accordance with S.4(1) of the Assessment Ordinance?



I am a lifelong Anglican Christian with wide ecumenical experience. I have lived in rural, remote and city parishes as a clergy partner.

I initially trained as a nurse, later working as a midwifery nurse educator, and with the Child, Adolescent and Family Health Service in the remote town of Coober Pedy.

On returning to Adelaide, I worked for seventeen years for the Anglican Board of Christian Education in the Diocese of Adelaide, which later became part of the Ministry Development Council. As a Ministry Development Officer, I was involved in parish consultations, lay ministry training, Resource Centre manager, Safer Ministry Training, workshops encouraging family faith formation, including as part of the editorial committee of a magazine called 'Family Matters', involving members from the Lutheran, Uniting and Catholic churches. With colleagues from the Uniting Church and Catholic Church, we taught the Certificate 1V course 'Christian Journey with Children' at the Adelaide College of Divinity.

In 2010–2015 I worked as the Regional Officer for SA/NT with Bush Church Aid, a mission agency which ministers in remote and regional areas of Australia.

I have been Chair of Scripture Union SA at a time of nationalisation and a member of church related boards and committees, a Professional Standards Episcopal Standards Tribunal member; Supervised Field Experience supervisor and part of Supervision of the Supervisors group; part of the Adelaide Diocesan RAP working group and currently a team leader for Anglicans for Makarrata; Examining Chaplain, Priest's Warden for the Parish of Coromandel Valley.

The strength of an organization lies in its members.

In other words, members need to be ready to meet the challenges facing the organisation. Without this there exists a very real possibility that the organisation will fall. I have seen this in a Parish I attended some 30 years ago.

For Church this means in our lay people, our Parishioners. For the Diocese it means members of Parishes who understand the bigger picture.

I believe I hold the necessary vision and understanding, and the courage to participate in finding solutions facing this Synod.

As a former Warden & Parish Councillor and current parishioner at St Augustine's Unley I accepted that responsibility. I would like to think I provided the leadership necessary to address significant hardships being experienced at the time. To allow the Parish to foresee (in the face of adversity) a future of hope.

I stand ready to accept that same responsibility on behalf of Synod. To join Diocesan Council for a second time.

Having previously served for one term on Diocesan Council I am aware of the challenges the Synod faces. Having likewise been a Synod rep for a substantial time, I believe I not only have my own insight but understand what Synod might be expecting.

The future of the Anglican Church is to be applicable to a generation much younger than what we see in Synod. I too may not be so young myself, but I do recognise that we must communicate with them in a language they understand. The message must be relevant to them.

The Parish leadership model style needs to recognize their approach to management. They are a group who are quite intelligent and learned. They are the most knowledgeable generation in human history.

Today's younger parishioner will expect to participate in the leadership of the Church. They will be less likely to sit back and simply take direction from their minister.

As for previous generations they will be looking for education and mentoring in the Word. They will, as we did, need pastoral care. These enduring attributes of the Priesthood will therefore still be needed.

Parishes (whether in the future or now) need to take responsibility for providing Priests the opportunity to provide these most important skills. To receive the blessing that Priests can and should provide, they need to ensure the Priest is not burdened with administrative issues, financial issues, property maintenance issues and the like.

In today's secular dominated world, our priests need all the help they can get. They deserve to follow unimpeded their calling. That is the calling of today's Lay, not only on Parish Council but in Synod and on Diocesan Council.

Maybe I am one such Lay.
